## RESPONSIBILITIES

The Environmental Heritage Coordinator will assist Green Venture's staff to execute environmental education outreach programming in the summer with children and adults, specifically as it relates to Canada's 150<sup>th</sup> and Canada's Changing Environment.

Working with the public in a courteous and friendly manner, the position will help promote sustainable living to children participating in school and summer camp programs at EcoHouse, as well as occasionally presenting to adults on similar topics.

Secondary tasks include assisting staff with the research, development and execution of Clean Air and Sustainable Transportation, Energy Conservation and Renewables Generation, Green Gardening, Climate Change, and Water Conservation programs.

This will also include developing EcoHouse indoor and outdoor demonstrations, and educational signage, assisting in communications by responding to phone and email inquiries related to programs and assisting in Green Venture programs' promotion at community events and presentations.

Other tasks as assigned.

Green Venture maintains an Internal Responsibility Program as part of Health and safety Program. All staff are active and engaged in assessing Health and Safety risks and seeking improvements.
