### **Participant Informed Consent, Waiver and Indemnity Agreement**

The completion of this form is mandatory for all participating members of the EcoStars Summer Camp Program. Failure to complete this waiver form and submit it to the Green Venture office will prohibit participation in the EcoStars Summer Camp Program.

#### **Summer Day Camp Program**

- I. I, the undersigned, have authority and do hereby give permission for my child to participate in the EcoStars Summer Camp Program at Green Venture. I also give permission for my child to participate in any field trips which may occur during the duration of the camp session. Such field trips may include, but are not limited to, Veevers Park, Red Hill Valley Trail, Felkers Falls, , local farmer's markets and farms.
- II. I do hereby acknowledge that there are certain risks of injury to my child, inherent in the participation in any outdoor recreation activity. These types of injuries may be minor or serious in nature and may result from one's actions or inactions, or the actions or inactions of others, or a combination of both.
- III. In the event of an accident or medical emergency, I hereby authorize Green Venture and its employees, representatives or individuals designated by them to consent to any emergency medical treatment on my own behalf on behalf of my child, by a qualified health practitioner.
- IV. I agree to indemnify, release and save Green Venture and their representatives, employees, interns and volunteers from any claims or demands which might be made against Green Venture arising out of or in consequence of the attendance or participation of my child in the program, including but not limited to personal injury or loss or damage to personal property or belongings unless such injury, loss or damage is caused by the sole gross negligence of Green
